¹ The Westside Water Authority is composed of the following member agencies: Belridge Water Storage District, Berrinda Mesa Water District, Lost Hills Water District, and Dudley Ridge Water District. This agenda also constitutes a special meeting agenda for any member agency in the event a quorum of its board of directors is present at this WWA meeting. However, all resulting special meeting agenda items will be for discussion only and no action will be taken by a member agency's board of directors with a quorum present at this WWA meeting.
